

AGREEMENT

THIS AGREEMENT, made the _____ day of _____, 2007, by and between the Board of County Commissioners of Tulsa County, Oklahoma, hereinafter called "Tulsa County" and the Board of County Commissioner of _____, hereinafter called "_____ County".

WITNESSETH:

WHEREAS, by virtue of 69 O.S., 1981, Section 1903, the Board of County Commissioners is authorized to enter into agreements with municipalities and or other counties to construct, improve, maintain and repair any of the streets of such municipalities or Counties, and;

WHEREAS, Tulsa County is desirous of participating in projects and the provision of services mutually advantageous to Tulsa County and other units of government;

WHEREAS, Tulsa County and other Counties located in CED #1 have jointly planned for standard traffic control signage on all public roadway systems in CED #1.

THEREFORE, in consideration of the covenants and conditions hereinafter contained, the parties hereto agree as follows:

1. Tulsa County agrees to furnish all materials, labor and equipment necessary to construct standard traffic control signage and to bill other governmental agencies for the actual material cost for the requested signage.
2. _____ County agrees to provide list of requested signage, to reimburse Tulsa County for the actual material cost and to pick up the requested signage at the Tulsa County Sign Shop 6601 N. 115th East Avenue Owasso, Oklahoma.
3. Either party hereto without the express written consent of the other shall not assign the rights, duties and obligations under or arising from this Agreement.
4. Duration of this agreement shall be for a one year period.
